

Hearings Process



- The Hearings Panel has issued a minute (Minute 6) that addresses procedural matters for each hearing. This includes:
 - The timeframe for Council to circulate the s42A Officer Report (recommendations on submissions)
 - The timeframe for all technical experts to be called at the hearing to circulate their evidence
 - The timeframe for any legal submissions to be circulated
- All parties must adhere to the timeframes and requirements set out in Minute 6, and any subsequent minutes that may be issued by the Hearings Panel
- Any variations to the directions contained within a minute is considered by the hearings panel

Councils Role in the Hearing



- Council engages an officer to complete a s42A report, which assesses
 the submissions received and provides recommendations as to
 whether to accept or reject the submission
- The s42A officer is an independent witness and provide their professional opinion. They are involved in the process to assist the hearings panel and make recommendations
- Technical advice from experts is sought to support the s42A officer in forming their view where required i.e. a landscape architect
- Submitters can respond to the s42A report at the hearing, and through the provision of expert evidence prior to the hearing

Councils Role prior to the Hearing



- s42A officers can seek additional information and/ or discuss submissions with those who submitted them
- This creates the opportunity to better understand the reasoning for submissions and what is being sought; whilst also seeking to clarify any potential misunderstanding or interpretation issues
- Discussion and understanding that can be gained during the development of the s42A report can result in clearer recommendations to the panel
- Staff in conjunction with s42A officers will seek to communicate and engage as much as possible during the pre-hearing period to seek to achieve a robust hearing process

Managing the Unknowns



- The government is promoting various changes to the resource management framework
- The resource management regulatory environment changes often, and councils are always operating in an environment of some regulatory uncertainty
- Any changes that eventuate will need to go through the legislative process to be enacted
- If the changes occur during the scheduled process the Panel will consider the impact of these (if any) within the context of the information already in front of them
- If a new process is required to address any changes this will be a decision for Council

Mechanism to Change the Proposed Plan



- Council can notify variations to the Proposed District Plan
- The Hearings Schedule includes placeholders for two hearings to consider variations to address:
 - Legislative changes requiring immediate implementation; and
 - The rezoning of FDA 1 and 2
- Careful consideration should be given to any future variation, as there
 will be associated cost and time implications to the project that have
 not been budgeted for
- Once a plan is operative and any appeals resolved Council can notify plan changes to make changes to their District Plan

Keeping Councillors Up-to-date



- Frequent reporting is proposed to the Environmental Services Committee to update on:
 - Overall progress of the District Plan Review
 - Adherence to timeframes
 - Any important issues that arise
 - Legislative change that impact on the district plan review
 - Any other matter that the Committee requires
