#### From the Processing team

#### ATTENTION DESIGNERS AND ARCHITECTS

#### Electronic Consent Applications are almost here:

As of the 1 July 2016, the Timaru District Council will be implementing the second phase of its electronic building consent project, electronic (online) applications. This means that applicants can submit their application and all attachments electronically and have it processed and issued back to them electronically as well. To be able to access this you will need to:

- Have registered a MyTDC account through the Council website www.timaru.govt.nz/home
- Be signed up to "RealMe", which is the official and secure way to prove who you are online - think of it as your online ID.

Once you have signed up you will be contacted individually to join this system, this will allow us to manage the implementation program as smoothly as possible. We will be doing this over a period of time and I ask that you bear with us as we move into this electronic era.

So that's about it for the moment, there will be more updates sent out as we move through this phasing-in period and if you have any questions, you can contact Jayson Ellis on 03 6877466 or jayson.ellis@timdc.govt.nz

Don't forget that you will be contacted in due course to be invited to join this system, so when you receive an email on this you will know what it is about.

Exciting times ahead!

But don't panic, the Building Unit will still be continuing the hard copy application service as normal. However with one small change, as of the 1 July we will be swapping the current LGNZ application forms (BA Form 2) for the much more user friendly Southern Cluster Group model. Refer to

### **BUILDING CONSENT PROCESSING TIMES:**

The processing team has reason to celebrate, with a huge effort, they have been able to process 100% of building consents since July 2015 within the statutory 20 day time frame. To do this, Jayson Ellis and his team have managed to juggle work flows with his team working overtime and sending consent applications to external contractors.

Another change to ensure consents won't go beyond the twentieth day was to treat minor consent applications as any other consent. For example previously all solid fuel heaters, marquees and other minor projects would be dealt with as they came in the door. Now they are processed promptly but along with other consents received. However, if you have submitted a minor consent application and have a legitimate reason for urgency, please make note of this on your application and we will endeavour to process it urgently.

- Enter your Building Consent Number (as written per acknowledgement letter)
- Search

This will detail the description of work, location of the property and detail all tasks to date.

As a similar procedure for granting a Building Consent, the Building Act also gives the Building Consent Authority (BCA) 20 working days to sign off when the project is complete.

### ONLINE TRANSACTIONS REQUIRE PROOF OF PAYMENT WHEN PICKING UP OR DROPPING OFF **BUILDING CONSENTS:**

An important reminder to customers who use the internet banking option to pay Building Consent fees: if you do this and expect to either deliver a consent application to Council or intend to pick one up, it is critical that you print off proof of the online banking receipt once you have completed the transaction and bring this into Council when delivering or receiving a building consent.



#### From the Inspection team

#### **SOLID FUEL HEATER INSPECTIONS:**

To ensure our inspection team can carry out and, most importantly, pass an inspection at the first visit the following points are critical:

- · Approved plans must be onsite
- · In the interest of the installer, it is advisable for them to be onsite during the inspection to rectify any minor issues
- · Inbuilt heaters with timber framed chimney voids will need an inspection

prior to closing in the void for the purpose of viewing flue clearances. Alternatively, leave a panel of lining off.

· Don't forget to check that the smoke detectors are working and are located at least three metres from the bedroom doors and on an escape route.

Doing the above checks will help avoid a further follow up inspection which comes at the cost of an additional inspection
