1. Introduction

Receipt of late submissions

The Timaru District Council ("the Council") notified the Proposed Timaru District Plan ("the Proposed Plan") on 22 September 2022. The submission period closed on 15 December 2022. After the closing date, a number of submissions were received by the Council some of which were lodged late and others which were procedurally deficient ("the late submissions").

Our appointment

On 14 June 2023 we, A.C.Hughes-Johnson KC, R.Day-Cleavin, Councillor O.Jackson and Councillor S.Scott, were appointed as commissioners to make decisions on late submissions to the Proposed Plan.

It is necessary to consider whether we should grant waivers in respect of the late lodgement of the late submissions and identified procedural deficiencies.

Commissioner Hughes-Johnson records that a number of decades ago, his father held an office in the Royal Forest and Bird Protection Society of New Zealand Inc. and he was a junior member of the Society. However, Commissioner Hughes-Johnson has had no association with the Society since that time and considers that this previous association does not in any way prevent him bringing an independent mind to bear upon these applications.

Issue of minute

On 15 June 2023 we issued a minute directing the provision of a report on the late submissions under sections 37 and 37A of the Resource Management Act 1991 ("the Act") ("the report") and the report was duly received.

On 22 June 2023 a minute was issued directing a supplementary report on a further late submission and a report was duly received ("the supplementary report").

2. The late submissions

The late submissions which require consideration are identified in Appendix A to the report which is **attached** to this decision.

On 22 June 2023, an additional submission was received from New Zealand Frost Fans Limited, contained in Appendix A to the supplementary report **attached** to this decision.

We record that we have considered the report and the supplementary report in reaching our decision.

3. Statutory framework

Jurisdictional provisions

The jurisdiction to decide whether to waive the failure to comply with the time limits or extend time is provided for under s37 and s37A of the Act.

S37(I) of the Act states.....

37 Power of waiver and extension of time limits

- (i) A consent authority or local authority may, in any particular case,-
 - (a) extend a time period specified in this Act or in regulations, whether or not the time period has expired; or
 - (b) waive a failure to comply with a requirement under this Act, regulations, or a plan for the time or method of service of documents.

Then S37A of the Act then sets out the requirements for waivers and extensions as follows ...

37A Requirements for Waivers and Extensions

- (1) A consent authority or local authority must not extend a time limit or waive compliance with a time limit, a method of service or the service of a document in accordance with section 37 unless it has taken into account-
 - (a) the interests of any person who, in its opinion, may be directly affected by the extension or waiver, and

- (b) the interests of the community in achieving adequate assessment of the effects of a proposal, policy statement or plan; and
- (c) its duty under section 21 to avoid unreasonable delay.

4. Our consideration of the late submissions

Relevant considerations

We now turn to comment upon relevant criteria for granting waivers before reaching our decision:-

(i) Interests of persons who may be directly affected by the extension of time

The interests of other submitters who would be affected by the receipt of the late submissions is a key matter for us to consider.

We note that Council has not yet given public notice of submissions under Clause 7 of Schedule 1 of the Act. Should we grant waivers in relation to late submissions, the late submissions will be included in the public notice yet to be published. This will give rise to the ability of those persons with an interest in the late submissions to make further submissions in response to matters raised in the late submissions.

(ii) The interest of the community in achieving adequate assessment of the effects of the Proposed Plan

We record that we have taken into account this matter in reaching our decision. The community has an interest in ensuring that the matters raised in the late submissions are able to be considered in order to ensure that a full assessment of the effects of the Proposed Plan can be made.

(iii) Duty under s21 of the Act to avoid unreasonable delay

Given that public notice of submissions under clause 7 of the First Schedule to the Act is yet to occur, we find that the

granting of waivers will not result in any material delay in the planning process.

(iv) The principles of natural justice

The principles of natural justice centre around the requirement for planning processes to be conducted in a manner which is fair to all parties with an interest in our treatment of the late submissions. We have carefully considered the interests of parties who could be affected by the granting of waivers in reaching our decision.

Specific reasons for lateness

We now turn to consider the specific reasons for the requirement for waivers :-

(i) Missing or incomplete Form 5/ lodgements on or before 15 December 2022

26 of the submissions received before the closing date were procedurally deficient. We find that no prejudice will arise to any other parties following a decision to grant waivers in respect of the procedural deficiencies in question;

(ii) Submissions lodged after 15 December 2022

As to those submissions (other than submission 157 and the submission received from NZ Frost Fans Ltd dealt with hereafter) which were filed after 15 December 2022, being the closing date for submissions, we have considered the reasons for lateness referred to in the report. The reasons include:-

- (a) a mistaken assumption as to the closing date for submissions;
- (b) an original submission "bouncing back";
- (c) delays allegedly caused by Covid staff shortages;
- (d) the impact of a fatal accident resulting in delay;

- (e) lateness due to ill health;
- a claim that a submission was sent prior to the closing date but not received;
- (g) a submitter alleging it was not consulted and only became aware of the implications of relevant provision of the Proposed Plan at a late date;
- (h) lodging a submission on the operative plan of the Timaru District Council rather than the Proposed Plan;
- (i) new ownership of an affected property.

We have concluded that in each case we should accept the reasons for lateness and grant the waivers required. We do not regard the delays in lodgement as giving rise to material prejudice or representing a disqualifying factor.

(iii) No reason for lateness given / Submission 157/Ryan de Joux

This submission was received on 17 February 2023 and no specific reason was given for lateness. The report states that accepting this late submission "could impose a burden on Council to further investigate with the potential of needing wider consultation with stakeholders and ratepayers within the district". For this reason, we have given special consideration to the question of whether we should grant a waiver in this case. Notwithstanding the degree of lateness, the absence of any reason for lateness, and staff concerns outlined above, we have concluded on balance that we should grant a waiver in this case. In reaching this decision we have been primarily influenced by the fact that the summary of submissions is yet to be completed and that any persons with an interest in the late submission in question will have an opportunity to respond to the late submission by lodging a further submission as public notification of submissions has not yet taken place. We find that it is appropriate for the matters raised to be tested through the Schedule 1 process along with all other matters raised in submissions.

(iv) Submission from New Zealand Frost Fans Limited

On 22 June 2023, a submission was received from New Zealand Frost Fans Limited. The significant lateness of the submission was acknowledged by the submitter, and reasons given for that lateness. The supplementary report recommended that we should not grant a waiver in this case, given the recommendation in the (first) report that no further submissions should be received after the date of that report. However, we consider that the reasoning recorded in (iii) above applies equally to this submission. Accordingly on balance we have concluded that we should grant a waiver in this case.

5. Conclusion

For the reasons set out above, we grant waivers in respect of the late lodgement of submissions and procedural deficiencies identified above in respect of all late submissions recorded in the staff reports attached to this decision. The effect of the grant of waivers is that all late submissions are accepted and will be included in the summary of submissions.

We therefore accept recommendations 4 (b) and (e) presented in the (first) staff report and recommendation 4 (b) presented in the supplementary report.

In order to ensure the orderly consideration of existing submissions by the Council and to prevent delay, we direct that no other late submissions are to be received by the Council from the date of the supplementary report, namely 23 June 2023.

Pursuant to s37A(6) of the Act we direct that notice of our grant of waivers is to be given to all hearing parties including submitters and that this decision is to be published on the Council's website.
