7 Reports

7.1 Extension of CBay Outdoor 50m Pool Season Petition

The Committee considered a report by the Recreation Facilities Manager on a petition requesting the extension of the CBay Outdoor 50m pool opening and closing dates.

The Aquatic Operations Team Leader was present for any questions and John Bradley, a pool user, represented the petitioners.

The petition seeks an extra two weeks to be added to the Outdoor Pool season, which for 2021, would take the season end to 4 April 2021.

The petitioner explained that the expected cost of heating and providing an extra life guard for these two weeks is understood, but he hopes that the extra usage would cover these costs.

The options were discussed and Option 3 - extending the season for all outdoor pools, was favoured, however it was suggested that the extension should be on a trial basis for the 2020/21 season.
