Held in the Peel Forest Cafe, Peel Forest
on Wednesday, 14 April 2021 at 6.30pm**

1 Apologies

An apology was received from the Peel Forest Preschool Chair Sarah Thatcher.

2 Public Forum

Allan Averis – Blandswood Ford and speed limit

Allan Averis, a resident of the Peel Forest area since 1940, attended to discuss his safety concerns relating to the Blandswood Ford and the speed limit in the Peel Forest village.

Mr Averis expressed his concerns over the condition of the current Blandswood Ford. Historical flooding events resulted in the original bridge (in 1975) being washed away with subsequent fords also being washed away/damaged over the years. Mr Averis felt there were safety risks associated with crossing this section of river to emergency services, residents (6 families), road users and visitors.

Mr Averis has been in contact with Timaru District Council's Land Transport Manager, discussing his above concerns and providing suggestions (ACL documentation) over the Blandswood Ford replacement. Mr Averis felt Council's Land Transport Manager listened and understood his concerns and that they would be addressed.

The Chair and Cr Oliver advised Mr Averis that the Blandswood Ford replacement was within the Timaru District Long Term Plan that was currently out for consultation (10 April – 5pm, 10 May 2021).

Mr Averis felt 70km was too fast for the Peel Forest Village with there being significant safety issues to residents and visitors. Mr Averis would like Council to reassess the speed restrictions potentially reducing the speed to 40km.

Matt Searle – Speed limits in Peel Forest township and road conditions

Matt Searle attended to discuss his safety concerns relating to the speed limit in the Peel Forest village and road conditions.

Mr Searle felt there were safety issues with the condition of the south bound approach road from Rangitata Gorge heading to Peel Forest and the north bound approach to boundary stream. These roads are heavily corrugated, experiencing significant increased vehicle use including heavy vehicles, are both blind approaches, narrow, hill ascent and descent, with gulleys and streams either side. These factors add to the hazardous and dangerous condition of the roads to users. Mr Seale

advised a sensible solution to these hazardous safety issues would be to extend the seal to the approaches to these areas much like the approach to White Rock.

The road speed limit within the Peel Forest village is also of concern. As the village and surrounding environs becomes more popular to residents and visitors the current speed limit needs to be reduced to ensure the safety of residents, visitors, road users and pedestrians. The current roading infrastructure doesn't cater for the recreational increase in traffic to the area. A temporary solution would be to extend the current temporary speed sign zone north of the village through the village with a permanent restriction being implemented in the long term.

The Chair, Committee Members and Timaru District Council, Road Safety Coordinator appreciated and understood Mr Searle, Mr Averis, the Preschool and the Peel Forest community's concerns. While in principle they supported and agreed it made sense to reduce speed restrictions, it was however an incredibly complex, lengthy and involved process – there is no simple solution. Road speed is a concern that is unfortunately not unique to the Peel Forest community. Driver education and awareness are aspects where some gains may be made. We are about to enter into the speed limit review within the next 1-2 years. Engineers are awaiting to implement the final process pending advice on who is to take the lead Government or Councils. This process will involve consultation and public/engagement/feedback, once the speed limit is agreed it will then be gazetted enabling NZ Police to enforce the speed limit. As an aside the current speed management options available are 50km, 60km, 80km and 100km, the option to use 70km is being phased out albeit where this speed restriction exists it is still legal. The Road Safety Coordinator will assess the road and what other road slowing measures may be suitable (if any).

McGregor Simpson – Speed Limit and Broom and Gorse growing on Council land

McGregor Simpson discussed his safety concerns relating to the speed limit in the Peel Forest area and Broom and Gorse growing on Council land.

Mr Simpson fully supported the Peel Forest village speed being reduced to 50km and the dangerous nature of the Rangitata Gorge Road. Mr Simpson suggested the speed reduction should go from Cain Flat to the School.

Mr Simpson suggested that the road on the West side of Kowhai Stream could be maintained and shingled, Blairs Road turn right 300m, then 1km alongside Kowhai Stream to Skidmores.

Mr Simpson expressed his concern in relation to the fire risk associated with the broom and gorse growing on Council forest plantations and land he felt this should be controlled/managed through spray and grazing.

Attended the Creative Communities meeting, OTOP meeting, Geraldine Community Arts Council and the Geraldine Transport Strategy Workshop. The Tourism Task Force has been wound up. The Arts of Tour Show – Cosmic is scheduled for July.

Jan felt the tree scape was diminishing and more thought and consideration should be given to suitable locations of appropriate tree species for future plantings.

Janene Adams

Discussed the issue of the concrete tree surrounds cracking with Council's Road Officer. There is unfortunately no simple solution and further investigation in relation to a suitable economic alternative is continuing. The dead tree replacement is progressing with some dead trees not being replaced as communications services run through the vicinity.

The two sets of bins outside the Gallery are being moved to the front of the Village Inn at the request of the owner.

The Geraldine Licensing Trust have committed \$5,000 to the Nature and Sculpture Trail Project.

Attended the Geraldine Transport Strategy Workshop.
