### 6 Consideration of Urgent Business Items

It was discussed that the Donations and Loans Subcommittee will consider excluding event funding, so that all events will apply through Venture Timaru.

It was identified that putting a cap on event funding could be an alternative, allowing small events to apply for funding, but medium and large events apply to Venture Timaru, who currently have a minimum event limit of \$10,000.00. Discussion was had about a \$3,000.00 or \$5,000.00 cap for event funding via Donations and Loans.

It was discussed that knowledge may be lost with funding for events being put in a commercial entity, with a key issue being "small" events may get lost or neglected, and that some events may miss out on funding because they do not fit any funding category. But, it could also be beneficial for events to have the support of Venture Timaru.
