We support this as the owner of Lot 2 DP 432561, which is located between 236 Meadows Road and Aorangi Road. We note that the Summary of Submissions sets out the GIZ zoning sough for 236 Meadows Road, but does not appear to reference the rezoning o the land between Aorangi Road and 236 Meadows Road, as sought in the submission: We note the two properties to the southwest of the site legally described as Lot 1 DP 432561 (ID: 78117) and Lot 2 DP 432561 (ID: 78118) have existing land use consents authorising industrial use. Furthermore we note that Councils existing waste water treatment ponds on the south side of Aorangi Road along with the Council land mentioned above to line up with the alignment of northern boundary of 236 Meadows Road, thus creating one contiguous zone.
