5.1 Contract 2636 - Upgrade Evans Street Watermain

1 To seek approval for tender acceptance for Contract 2636 – Evans Street watermain upgrade.

The GM infrastructure spoke to the report on the renewal of existing water main, down by showgrounds. Pipe is in the carriageway and at end of left, and the contract will renew and route down footpath to reduce future costs. Three tender. One tender at a good price, and have competency to do work with a good track record. This is a Lowest price conforming tender so there is choice of accepting this tender or going back to market..

It was noted that although this is in the NZTA corridor it is our asset, so the cost is with us. We will be abandoning the previous pipe, filling it with grout and that will be our obligations covered.

Lot of other services in the area, so wasn't suitable for drilling.

There was discussion about post contract reviews, to see if the cheapest is still the cheapest. The tender evaluation method meant this could be public.

There was discussion around the Douglas Street works and the issues there, it was noted that the contractor was paid for the job, not specifically the time it took.
