#### 9 Reports

#### 9.1 OTOP Water Abstraction Data

The Senior Science Analyst, Environmental Canterbury, and Team Leader Surface Water Resources spoke to the report and gave a presentation to update the Committee on Water Abstraction from the Opihi Catchment.

The presentation of water abstraction points, data management and use, data issues, catchment complexities, catchment abstraction, and allocation.

Discussion included mechanisms for unused allocation that are not surrendered. The process of allocation from the Opuha dam company, the struggling water levels in the rivers, and the process of changing the allocation amount.

It was highlighted the importance of this data and its use for future decision-making. The effect of water restrictions on water allocation and abstraction. The data limitations and calculations for monthly allocations were clarified.

Further discussion included the charging from Opuha Dam company to farmers, water storage, unused allocation, use of other irrigation schemes and other water sources by farmers, and the impact of Resource Management Reforms.

#### Discussion

#### **1** Te Kete Tipuranga o Huirapa Ltd (Arowhenua Native Nursery)

Felicity McMillan, General Manager Arowhenua Native Nursery and Restoration, will present an update on the Ōpihi Lagoon plant maintenance activities (2022/23 AP Grant - \$15,000) and a general update on the activities of the Nursery.

#### 2 Te Kopi-O-Te Opihi (Burkes Pass) Heritage Trust

Funding Report for OTOP Grants to Te Kopi o Te Opihi Restoration Group

1) Grant Agreement Number: 1191-112, date 01 July 2023 (\$5,728.60)

Deliverables - to continue to focus on:

- fencing
- willow control
- planting and plant production
- mulching and releasing of plants
- predator control
- water quality monitoring
- 2) Grant Agreement Number: 118, date 29 Jan 2024 (\$12,340)

#### Deliverables

Supplementary planting of grasses stage 1 and 2 (\$7,720) - completed

Release and mulch stage 0 and 1(\$4,620) - completed

The financial summary contains more detail of the multiple transactions which have been extracted from the accounts of BPHT for this project.

Notes on Progress and Outcomes

- Fencing was maintained at status quo until 2025 when major progress was made with installing rabbit proof netting which also excludes wallabies – still to be completed.
- Willow control was a major expense but completed 2/3 of the river segment and mulch of the slash became a significant resource for survival of new plantings in significant drought 2023-24, however watering was also required for a limited time period for new plant survival.
- Planting and plant production has enabled coverage of stage 0- stage 2 with plants purchased from Arowhenua Native Nursery Ltd, and also BPHT nursery greatly increased its

production. OTOP funding has enabled significant supplementary planting, however this will be an ongoing process over years as biodiversity is enhanced with propagation of more diverse and rare slow growing species.

- There have been many hundreds of hours of voluntary work in mulching and releasing of plantings (both with scrub cutter, spray and hand weeding), tending to the BPHT native nursery, planting and tree work.
- Predator control has continued in a limited form, is planned to be extended in 2025 and an additional 3 x live capture cages used with success particularly for feral cats.
- Water Quality monitoring planning and monitoring commenced in 2024 with assessment and advice from EOS Ecology Ltd and Wai Connection, and eDNA from Living Landscapes Trust.

Other initiatives have included:

- A community event, River Wildlife Day, was held on 1<sup>st</sup> March 2025.
- Wildlife camera purchased and used to record predators.
- Drone footage of the project has been recorded with monitoring points that will be used for repeated image capture over time.
- Still photo points installed and images recorded.

#### Final Project Comments – Overview

It is my opinion that the OTOP funding enabled stakeholder synergies and involvement. Phil Brownie was an outstanding project manager, with the ability to leverage support and resources for what has become a substantial planting.

Key milestones beyond the OTOP application have been:

- DOC's decision to mulch all the slash generated from the felling of nuisance poplars and pines. A small area of ground was also cleared of tree trunks and noxious weeds (blackberry, old man's beard and elder). This opened-up the entire area and will facilitate on-going weed management.
- Provision of a large quantity of mulch from the Timaru District Council to support the establishment of the young plants.
- Mulch was spread and holes for plants dug by Tony Brady of the Pleasant Point Lions Club. The club has also provided and erected posts to take two 1000 litre IBC containers for storage of water. The tanks to be filled using daily Downlands stock water supply from my property and will be used during the establishment phase.
- An extension to the number of plants provided by the Central South Trail started at 380, extended to 500. 130 plants donated by Opihi Environmental Services and approximately 100 additional plants donated by me, with an additional 50 from friends, neighbours and family.
- Community response was excellent, with over 50 people turning out for the planting day. These included members of the Pleasant Point Scouts, Pleasant Point Lions Club, Central South Cycleway, pupils from Craighead, Mackenzie and Roncalli Colleges, neighbours and Cave residents.

On-going care and maintenance of the area is to be undertaken by members of the Pleasant Point Lions Club. This will require a community agreement with the Department of Conservation. Specific details are yet to be supplied to me and will include the two post planting sprays approved under the OTOP funding.
