Annual Report to Alcohol Regulatory and Licensing Authority for 2016/2017

Purpose of Report

1. To acquaint the Committee on liquor licensing matters and to seek endorsement of the Annual Report to Alcohol Regulatory and Licensing Authority (ARLA).

Background

- Section 199 of the Sale and Supply of Alcohol Act 2012 (the Act) requires that within 3 months after the end of every financial year each territorial authority must prepare and send to ARLA a report of the proceedings and operations of its district licensing committees during the year. The Annual Report was sent to ARLA on 18 September 2017.
- 3. As per previous annual reports ARLA has specified the form and content required in the report.
- 4. This report is a public record for the purposes of the Act and a copy must be made available for inspection on the Council's website for a period not less than five years. ARLA or the DLC must, on payment of any reasonable fee it has prescribed, provide a copy of each report to any person who asks for one.

5. The provision of an annual report is a statutory requirement.

Introduction

The purpose of this report is to inform the Alcohol Regulatory and Licensing Authority (the Authority) of the general activity and operation of the Timaru District Licensing Committee (DLC) for the year 2016 - 2017.

There are three DLC's operating in the South Canterbury area under a single Commissioner, this model having been adopted during the implementation of the Sale and Supply of Alcohol Act 2012 (the Act) in December of 2013. The three DLC's are that of the Timaru, Waimate and Mackenzie Districts.

This report will relate to the activities of all the DLC's in the body of the text and to the Timaru DLC alone in the Annual Return portion of the report at the rear of this document. This satisfies the requirements of the territorial authority set out in section 199 of the Act.

Overview of DLC Workload

DLC Structure and Personnel

The table below shows the current membership of the three DLC's under the Commissioner. Councillor Chris Clarke joined the Mackenzie DLC following former Mayor Claire Barlow's resignation in October 2016. No other changes occurred during the reporting period.

Total costs for the period amounted to \$15,527.28. This was made up of elected members allowances, travel costs, administration costs and solicitors fees.

In terms of Council staff delivering licensing services to the community and the DLC, there are 1.3 FTE licensing inspectors and a licensing administrator and the secretary to all three DLC's. In August of 2017 Secretary to the Timaru DLC Chris English took up another role out of district and consequently resigned. The new Secretary to the DLC is Paul Cooper.

Of note current staffing levels are at capacity given the number of applications processed, monitoring requirements and enforcement functions they carry out across the three districts.

Staff Training

One DLC training session was held during this period.

Hearings

Local Alcohol Policy

The Timaru, Mackenzie and Waimate District Councils jointly prepared a draft Local Alcohol Policy. In preparing the policy, the views of the community about alcohol licensing matters were sought through community surveys, a consultation process and discussions with key stakeholders a policy was drafted. Following consultation and hearings on the draft policy (and subsequent changes) it became a Provisional Local Alcohol Policy (PLAP). Once the appeals against the PLAP were resolved, the Councils and ARLA were satisfied with the LAP and it was adopted. The PLAP became the LAP on 21 December 2015.

The LAP was evaluated by the Timaru, Waimate and Mackenzie District Councils in June 2017 and found to be performing well. Stakeholders were consulted with during the evaluation process. Each Council found the policy to be fit for purpose and will now be reviewed at the frequency prescribed by the Act.

Additional Resource Consent Monitoring Charges

Report Purpose

To determine whether Timaru District Council should or should not require resource consent holders to pay additional monitoring charges.

Background

- 2 Section 35(2)(d) of the Resource Management Act 1991 (RMA) states that:
 - "Every local authority shall monitor -...(d) the exercise of the resource consents that have effect in its regional or district, as the case may be."
- The ability to charge for that monitoring is provided by Section 36 of the RMA. The 2017/18 Annual Plan fees and charges provides that a single site inspection fee of \$200 is paid for monitoring resource consents upon lodgement of the application. It also states that additional monitoring fees will be charged at cost, which is \$130 per hour.
- 4 Historically Council has not charged resource consent holders to monitor resource consents. As there is good reason to charge monitoring fees, the Committee is now requested to determine whether additional monitoring fees will be charged on an "as and when required" basis.
- 5 The reasons for charging additional monitoring fees include:
 - a. The need for consent monitoring is created by consent holders.
 - b. Consent monitoring creates significant costs for Council, which are currently not being fully recouped.
 - c. Consent holders benefit from being allowed to conduct the activity to which the consent relates. Therefore it is appropriate that they pay the cost of monitoring that consent.
 - d. The RMA creates an expectation that monitoring fees will be charged.
 - e. The need for multiple monitoring visits is normally a result of the consent holder not complying with consent conditions, therefore it is appropriate that they are charged for that cost.
 - f. Charging additional fees will assist with achieving compliance.
 - g. The additional monitoring fees will assist in covering the costs of providing the monitoring service.
 - h. The costs of providing all other district planning services available to the public are recouped through user fees and charges.

- The amount of monitoring visits can vary significantly from one visit to numerous visits. For instance, some consents are required to be monitored periodically on an on-going basis, while other consents may have regular non-compliance and therefore require regular monitoring.
- Council's Revenue and Finance Policy adopted as part of the Long Term Plan (LTP) states that fees and charges is one of the sources for funding operational expenditure. It also states that Council will review fees and charges to maintain cost recovery levels. Specifically in relation to the district planning activity, the Revenue and Finance Policy states that it is funded by 70% general rates and 30% by user fees and charges. As such if monitoring costs are not funded by the fees and charges, then they will be funded by general rates. The Revenue and Finance Policy also acknowledges the benefits from the district planning services generally accrue to users of these services, although it also acknowledges there is an element of wider public benefits of the service).

Options

- 8 The key options in relation to this matter are:
 - a. Do not charge additional monitoring charges.
 - b. Charge additional monitoring charges as and when required.
- 9 The positives and negatives for additional monitoring charges are:
 - a. Positives:
 - The additional monitoring fees will assist in covering the costs of providing the monitoring service.
 - The additional monitoring fees will reduce rate payer contribution to monitoring costs.
 - Charging additional fees will assist with achieving compliance.
 - b. Negatives:
 - More costs on consent holders.

Identification of Relevant Legislation, Council Policy and Plans

Assessment of Significance

10 This matter is not deemed significant under the Council's Significance Policy.

11 The Group Manager Environmental Services, the Acting Group Manager Environmental Services and the Environmental Services Chairman have been consulted on this matter.

Other Considerations

12 There are no other relevant considerations.

Funding Implications

13 It is expected that additional monitoring charges will generate \$20,000 to \$60,000 of fees per annum. Those fees will help pay for the cost of providing the monitoring service.

Conclusion

14 That the Committee should determine whether consent holders pay additional monitoring.

Recommendations

- 1 That the report be received.
- 2 That resource consent holders be charged additional monitoring fees as and when required in accordance with the relevant adopted fees and charges.
