#### Election of Chairperson for Agenda Item No 1

#### Recommendation

- 1. That the Board select the voting system to be used for the appointment of the Chairperson and Deputy Chairperson.
- 2. That a Chairperson of the Sister Cities Committee be appointed.

#### **Purpose of Report**

- 1 To select a voting system for the appointment of a Chairperson and Deputy Chairperson.
- To nominate and appoint a Chairperson to the Sister Cities Committee. The Mayor will call for nominations for the position.

#### Discussion

When electing a Chairperson or Deputy Chairperson, the Sister Cities Committee must decide by resolution to use one of the following two voting systems:

#### 4 System A—

- (a) requires that a person is elected or appointed if he or she receives the votes of a majority of the members of the Community Board present and voting; and
- (b) has the following characteristics:
  - (i) there is a first round of voting for all candidates; and
  - (ii) if no candidate is successful in that round there is a second round of voting from which the candidate with the fewest votes in the first round is excluded; and
  - (iii) if no candidate is successful in the second round there is a third, and if necessary subsequent, round of voting from which, each time, the candidate with the fewest votes in the previous round is excluded; and
  - (iv) in any round of voting, if 2 or more candidates tie for the lowest number of votes, the person excluded from the next round is resolved by lot.

#### 5 System B—

- (c) requires that a person is elected or appointed if he or she receives more votes than any other candidate; and
- (d) has the following characteristics:
  - (i) there is only 1 round of voting; and
  - (ii) if 2 or more candidates tie for the most votes, the tie is resolved by lot.
