8 Consideration of Minor Nature Matters

Group Manager Environmental Services advised there were no reports that required consideration at this Committee, but the following areas were updated for the Committee:

The Draft District Plan

There have been 18 one on one meetings on a range of topics, 3 community meetings with local Hut residents and land owners were invited to workshops on the effects of Coastal Hazards.

The Community Boards have had presentations at their meetings, and there have been meetings held or coming up with the Chamber of Commerce, Federated Farmers, PrimePort, Venture Timaru and the CBD Executive. A deadline was set for 30 November for feedback, however the team will continue to receive this feedback up until Christmas.

The Planning Team are seeking as much feedback as possible, and encourage Councillors to assist any community members by directing them to the EPlan, or to contact Planning staff directly.

An apology was made for the upset caused by the error in the Draft Plan in regards to Rural Boundary Setbacks, the error is to be corrected, and will be included as a change for the proposed plan.

All changes are tracked so therefore highly transparent. There was disappointment that Council was not contacted by the media to comment on this story, before it was published.

Buildings

The move to online processing is due to go live at the end of this week, the building team are working closely with the industry and builders. This is a large project, coupled with significant activity leading

up to Christmas which is slowing down processing of contents currently, and resources are being utilised as much as possible.

City Hub

There is a drop-in session today between 4 and 6pm and then a presence at the Artisan market on 12th December. Already there has been good feedback and thoughtful submissions received.

A draft is expected to be presented to Council early 2021.
