- Details of who will carry out the construction supervision. Including their relevant experience / qualifications.
- Two sets of **Plans** printed to an acceptable scale on A3 paper clearly showing:
 - the extent of construction as per the Timaru District Council accepted preliminary plan.
 - the location and details of any underground services.
 - the extent of any earthworks.
 - component diagrams where required. (*e.g. Stormwater sumps, Manholes.*)
 - the location and details of any proposed landscaping.
- Two sets of **Long Sections** printed to an acceptable scale on A3 paper clearly showing:
 - cut, fill and finished levels.
 - location of any underground services.
- Two sets of **Cross-sections** printed to an acceptable scale on A3 paper clearly showing:
 - pavement depths and material details.
 - finished cross-fall.
 - location of any underground services.
- A signed and completed **Engineering Design Certificate** (*see next page*)

Note: *The enclosed **Contractors Completion Certificate** and **Engineers Completion Certificate** do not need to be provided to the Timaru District Council at application for Engineering Design acceptance. These certificates will need to be provided prior to the Timaru District Council final certification of the works.*
