1 PUBLIC FORUM - Timaru Penguin Group and Forest and Bird Society South Canterbury

Kimberley Collins and Peter Bennett presented a petition with 1722 signatories on behalf of the Timaru Penguin Group and local Forest and Bird Society, calling on councillors to protect blue penguins through regulations around dog access to Caroline Bay. Both organisations wish to emphasise the benefit of the little blue penguins to the local economy and the enjoyment of the bay by locals and visitors.

Ms Collins said the group appreciated Council listening to its views, and believes it will be a win for Timaru as a tourism feature, a win for the penguins and a win for Timaru families. She thanked Council for going beyond what the petition has requested.

The Mayor congratulated the group on how organised it had been and having the confidence to present to Council. It is a good example of democracy at work and giving the community a voice.
