1 CHAIPERSON'S REPORT

The Chairperson reported on meetings he had attended and duties he had carried out on behalf of the Board since the last meeting, including several Geraldine Combined Sports meetings, Geraldine Anzac Commemoration Trust meeting, Meet the Candidates evening (for Central Government elections), Go Geraldine, meeting regarding the visitor sign and the Geraldine Vintage Car and Machinery Club.

Correspondence and contacts have included a letter from Transpower which was read at the meeting, advising of work planned near Orari to establish two switching stations – this matter is being handled by Council officers, communication from the District Planning Manager in response to the Board's queries regarding Waihi Terrace banners confirming that the NZ Transport Agency will not permit such banners along the State Highway; Christmas banners advice has been circulated; discussion with Geraldine Lions and with the Parks and Recreation Manager regarding new bins associated with the new Lions Club picnic shelter; a letter from a resident regarding a potential hazard on the river walk - the meeting was advised that the Parks and Recreation Manager is addressing the concern; the CBD refresh public meeting is tentatively proposed for November.
