Toilet for Temuka Cemetery	

Purpose of Report

1. The purpose of this report is to obtain the Board's recommendation for the placement of a new public toilet at the Temuka cemetery.

Background

- 2. The Temuka cemetery is located at the Domain Avenue / Murray Street corner, at the eastern end of the existing residentially developed area of the township. There is currently no existing toilet facility at the site, which is to be expanded to cater for future demand for burial sites. There is also a walking track being developed through the township, essentially following the Taumatakahu stream, which will terminate near to the cemetery.
- 3. The current cemetery site has provision for up to 90 further plots. There is a 35 year Resource Consent in place since 2015 to expand the cemetery onto adjoining land, which would provide 1000+ additional plots.
- 4. The need for such a facility was raised in consultation with the Parks and Recreation unit, owing to the envisaged increasing use of the walkway and cemetery.
- 5. A key issue is the type of toilet to be installed on site. The proposed site is shown dotted red on the attached aerial photo. As the existing services are located on Murray Street, the most appropriate type of facility is deemed to be a portable, self-contained, accessible toilet, of the type installed on Maude Street recently. Such a facility will require a concrete holding tank to contain waste matter and allow clearance of the tank as required by a commercial vehicle. Alcohol soap would be provided for hand washing. To screen the facility, planting and trellis would be put in place.

Options

6. To achieve the desired outcome, and given the lack of underground services immediately adjoining the optimum site, the recommended type of facility is proposed as the option going forward.



- 7. Another option is to do nothing. This is not considered appropriate given the anticipated requirement, and increasing number of public in the vicinity.
- 8. Another option is to consider another location for the facility, closer to underground services on Murray Street. The only possible location identified hatched blue on the aerial is thought to be known as 'free ground', an area traditionally available to those interred without a headstone. It is preferred not to disturb this vicinity.
- 9. In addition to this, if a clear site was found, is the cost of trenching the road to install a connection, and additional pipe services to a site. Cost estimates for these services are expected to add \$12,000 \$13,000 to the installation, based on information from the Drainage & Water unit.

Funding Implications

- 10. The cost of Option 1, estimated at \$17,000 includes the cost of installation of the facility, including holding tank and other modifications, (\$12,000) and screening material (\$5000).
- 11. Option 2 has no cost, but does not achieve the outcome sought.
- 12. Option 3 adds more cost to the installation, as well as potentially creating a disturbance element to the use of the land, which is not desirable.
- 13. Option 1 is preferred. The installation of the preferred option will provide a new service to the community, and meet community outcomes.
- 14. There is no currently approved funding allowed for in this financial budget year (2018/19). The estimated budget for the preferred option is \$17,000. With a contingency, an estimated \$20,000 should be allowed for the project.
- 15. An application for funding the project in the following financial year (2019/20) will require an application and approval by the Senior Leadership Team, and ultimately, Council.

Identification of Relevant Legislation, Council Policy and Plans

Assessment of Significance

16. This matter is not deemed significant under the Council's Significance and Engagement Policy.

Consultation

17. Consultation has been undertaken internally with Council units regarding location, land use and options for connections to services. It is understood that the Board has received feedback from members of the public suggesting the need for the facility.



18. The Parks and Recreation unit prefers the indicated site, because of distance from adjacent plots (8-10 metres).

Other Considerations


19. There are no other considerations relevant to this matter.

Conclusion

20. The requirement for the installation of the facility has been outlined, with the future expansion of the cemetery and the new walking track. There are no other such facilities for the public within a kilometre of the site. With the advent of expanded facilities at the cemetery and the new walkway use expected to attract increased numbers, the value of adding such a facility will lead to enhanced customer service levels.

Recommendations

- a That the Community Board considers which option should be pursued.
- Should Option 1 be the preferred choice, it be recommended that an application for the funds be made to the forthcoming Annual Plan for the 2019/2020 financial year.
