- ▶ **Draft District Plan**
 - ▶ Not formally proposed
 - ▶ First cut, for consultation
 - ▶ Non-statutory



Key Facts

▶ Intention of the Māori Purpose Zone

- ▶ Provide for the needs & wellbeing of landowners
- ▶ Create a thriving & self-sustaining Māori community

Draft Process?

1. Landowner Hui #1
 - Landowner representatives confirmed
2. Steering Group Meeting
3. Landowner Hui #2
 - Feedback on revised provisions
4. Steering Group finalises draft provisions
5. Council workshop

Statutory Process

7. Council adopts Proposed District Plan
8. Notification Proposed District Plan
9. Submissions
10. Further submissions
11. Hearing
12. Decision
13. Appeals
