## 2. Executive Summary

A designation is a planning tool used by Ministers of the Crown, local authorities and network utility operators approved as requiring authorities under s167 of the Resource Management Act 1991 (RMA). Only requiring authorities can seek designations for land.

This overview report sets out the designations included in the Proposed District Plan. This includes those that requiring authorities have requested be 'rolled over' from the Operative District Plan, and proposed new designations.

Where a modification to an existing designation is proposed, the proposed modification and the reasons for it, as advised by the requiring authority, are described.

For every new designation proposed as part of the Proposed District Plan process, an individual Notice of Requirement has been lodged by the Requiring Authority. These reports are available separately.

The Proposed District Plan includes designations from these requiring authorities:

1. CNZ – Chorus New Zealand Ltd
2. CRC – Canterbury Regional Council
3. KRH – KiwiRail Holdings Ltd
4. MSNZ – Meteorological Service of New Zealand
5. MEDU – Minister of Education
6. MPOL – Minister of Police (New Zealand Police)
7. NZTA – New Zealand Transport Agency
8. SPK – Spark New Zealand Trading Ltd
9. TDC – Timaru District Council
10. TPR – Transpower New Zealand Ltd

## 3. Overview and Purpose

### 3.1 Introduction

A designation is a planning tool provided by the Resource Management Act. This tool is used by Ministers of the Crown, local authorities and network utility operators approved as requiring authorities under s167 of the RMA. Only requiring authorities can seek designations for land.

Historically, designations enabled central, local government and network utility operators to get planning authorisation for public works and protect land for future public works. Requiring authorities can only make a designation where they are financially responsible for the project, work, or operation on the designated land.

A designation is an area specific planning provision. The designation authorises the requiring authority's work and activity on the site, area or route without the need to comply with the land use rules of the district plan. A designation has a similar effect to a plan change establishing a permitted activity as it:

- identifies the land affected in the district plan;
- enables a requiring authority to undertake works in accordance with the purpose of the designation within the designated area without the need for a land use consent;
- sets the parameters under which the activity can occur.

A designation restricts anyone other than the requiring authority from carrying out work on the designated land that will prevent or hinder the project or work to which the designation relates, without first obtaining the permission of the requiring authority.

The 'underlying zone' of the district plan remains over the site and applies to any other activities that are for a purpose different to the designation purpose (or activities undertaken by a party other than the requiring authority). Therefore, any activity or works outside the scope of a designation will require resource consent unless the activity or works are a permitted activity within the underlying zone.

## 3.2 Regulatory requirements

### 3.2.1 'Roll-over' designations

Schedule 1, clause 4 of the RMA enables a Proposed Plan to 'roll-over' existing designation with or without modifications. Requiring authorities with designations that have not lapsed must be invited to give written notice whether they require the designation to be included, with or without modification, in the proposed district plan. Where a modification is proposed, the requiring authority must provide the nature of the modifications and the reasons for them.

'Rolling over' an existing designation allows that designation to continue, without the preparation of new Notice of Requirement, which is the process whereby a new designation is created.

The level of detail associated with the reason for a modification varies depending on the nature of the modification. The reason for a minor modification may be quite brief, while the reason for a more substantial modification will be accompanied by an assessment of environmental effects. In making an assessment of whether a modification is minor, the following criteria have been used:

1. the modification involves no more than a minor change to the effects on the environment associated with the use or proposed use of land; or
2. the modification involves only minor changes or adjustments to the boundaries of the designation.

These criteria are consistent with the requirements in s181(3) of the RMA, which allows small alterations to designations without following the process for a new Notice of Requirement.

### 3.2.2 New designations

Where a Notice of Requirement for a new designation is proposed, the council may, with the consent of the requiring authority, include the requirement in the proposed district plan process rather than the separate process for including a designation in an operative district plan.

The following new designations are included in the Proposed District Plan:

1. Minister of Education (MEDU-24 – MEDU-28)
2. Chorus New Zealand Ltd (CNZ-14)

The supporting information is included in the Notice of Requirement (NoR) provided by the relevant requiring authority for each designation. These notices are available at <https://www.timaru.govt.nz/pdp-supporting-info>.

Including the NoR does not mean Council accepts the NoR. It only means the proposal enters into the public notification phase.

### 3.2.3 National Planning Standards

The following aspects of the National Planning Standards are relevant to this topic / issue:

1. Standard 9 – Designations Standard



The Designations Standard requires the district plan to contain a separate chapter for each requiring authority, containing the information for each designation as set out in the Standard. Where a requiring authority is listed in the Standard, the unique identifier code listed in the Standard must be used.

## 2. Standard 14 – Definitions Standard

The Definitions Standard requires that, where terms defined in the Definitions List are used in the district plan and the term is used in the same context as the definition, the definition as defined in the Definitions List must be used. Additional terms may be defined only where they do not have the same or equivalent meaning as a term defined in the Definitions List. Some designations contain conditions that use terms with equivalent definitions as defined terms, and so modification to comply with the Standard is required. For example, the Operative District Plan term “dwelling” must be replaced with the Planning Standards term “residential unit”, as they have an equivalent definition.

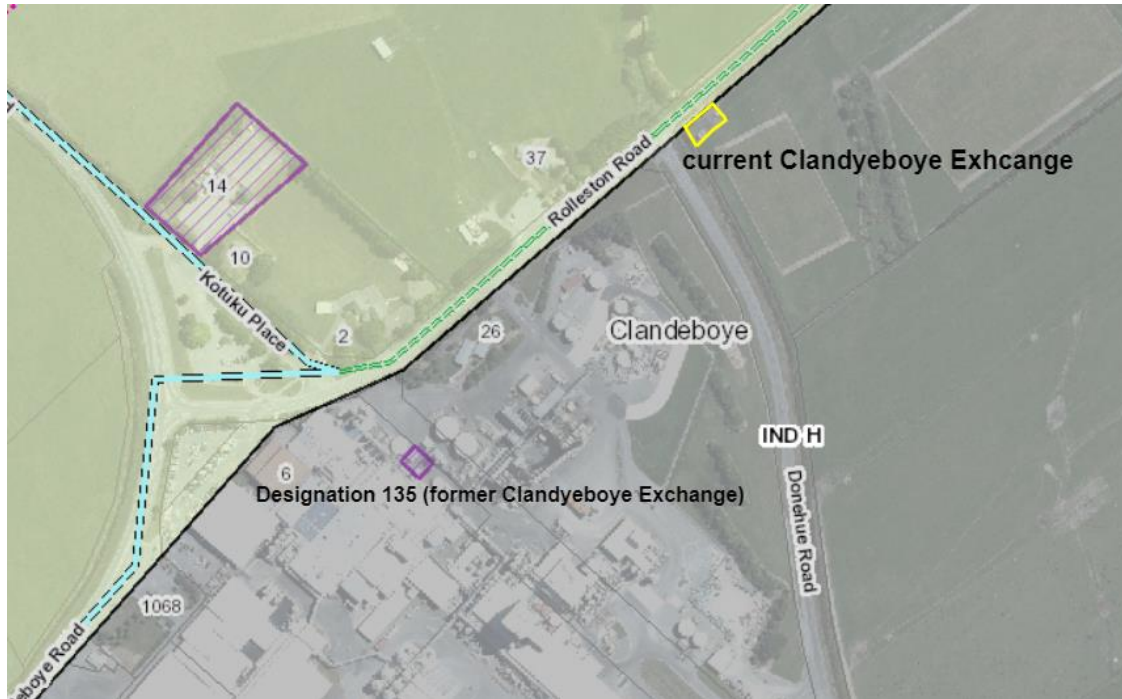

### New Designation/Minor modification

1. Co-location of former Exchange station.

In 1993 Subdivision Consent 3026 indicated that the Clandeboye Exchange within Fonterra factory (legal description RS 38157) will be relocated approximately 300m north east on Rolleston Road legal description Lot 4 DP 75226, which is owned by Telecom Mobile Limited. In 2008, resource consent 6858 was granted to establish, operate and maintain a new mobile phone site at Lot 4 DP 75226. The resource consent stated that the new site co-located with the Telecom Clandeboye Exchange site but no change to designation was proposed at the time of the application. The new site was established and in 2009 and has been operating since.

The facility has been shifted from RS 38157 onto Lot 4 DP 75226 as shown below.



At the time of Subdivision DP 75226 (RC3026), the application stated that Lot 4 is intended to be a utility site for the new Telecom exchange. It further explained that the existing exchange on Canal Road is to be shifted to this new lot. In 2008, resource consent 6858 was granted to establish a mobile phone site including:

- A 20 metre (m) high tubular steel mast with a three-way, twin-arm head arrangement as shown on the plans submitted with the application. The diameter of the mast is approximately 0.6m. The mast will either have a galvanised finish or be painted grey.
- Twelve panel and six omni antennas affixed to the mast heads. The panel antennas will measure approximately 2200 millimetres (mm) in height by 410mm in width by 200mm in diameter, extending to approximately 20m in height. The omni antennas will measure approximately 4m in length and 50mm in diameter, extending to approximately 24m high. The antennas are manufactured with a grey finish.
- A 3m long x 2.4m wide x 2.7m high equipment cabinet on a 0.5m high concrete pad foundation and located adjacent to the mast. The equipment cabinet will be coloured green.
- Two small GPS antennas erected on the equipment cabinet.
- Addition of hardware associated with the antennas, such as antenna supports, mast-head amplifiers and lightning protection rods, mounted near the top of the mast.
- Power and telecommunication connections will be from the nearest suitable source within the road reserve.
- Site access for construction and maintenance purposes will be via Rolleston Road.

Given the co-location has been sufficiently considered under resource consent, site is well established, the area of designation is small, the surrounding rural and industry environment and any further works would require an outline development plan, it is considered effects on this change is no more than minor. Accordingly, the change meets the criteria for a 'Roll-over' designation.
