If you are considering completing any building work that you believe may not require a building consent, please take notice of the following information. It is important to note that building owners are responsible for ensuring that ALL building work complies with the New Zealand Building Code (whether a building consent is required or not), the Council's District Plan and the Resource Management Act.

Exempt Building Work is building work that is covered by Building Act 2004, Schedule 1, and any subsequent amendments. Exemptions do not provide an approval under the Resource Management Act, or any other Act.

Approval must be sought from the Council if you wish to have an exemption considered under the Building Act 2004, Schedule 1, Clause 2 of Part 1 (a discretionary decision).

If your proposed work is covered by clauses of Schedule 1 (other than Clause 2 of Part 1), then you may still apply to have that work recorded. This will allow a copy of the exemption and plans to be placed on your Council Building File for reference in the future, e.g. if the property should be sold and a Land Information Memorandum (LIM) requested, the information will show on the LIM.

You should complete an Application for Exempt Building Work (BA Form 103 and BA Form 103A for discretionary decision) and return it to the Council with the appropriate fee (see Fees & Charges Information Sheet (IS-101)).
