Sound Splash

On 17 - 19 January 2020 Sound Splash hit Timaru!

The organisers were granted a special liquor license for the weekend and were happy to meet the conditions that were required by reporting agencies and all stakeholders (including FENZ). Preparing for the event, and making sure that everything went smoothly, meant a lot of work for everyone involved.

The organisers seemed happy, the public seemed happy, and the people that went to any part of the concert certainly appeared to be enjoying themselves.

As a Tri Agency, Liquor Licensing, Police, and Community and Public Health monitored the event over the two days that the venue was licensed to serve alcohol. The after party in town was also monitored.

A Temporary Liquor Ban was put in place which included the beach area and partway into the sea which worked well for the duration of the event.

Monitoring the event was enjoyable and the organisers had gone to great lengths to ensure everyone's safety and that everyone had a great time. There was plenty of security, St Johns Medics and a Health and Safety Officer on duty at all times. The organisation Deepspace set up camp stretchers and had personnel on hand to help with anyone that may have over indulged in some way.

Security staff at the gates were searching people on entry, which prevented some unwanted contraband being brought onto the site. There was no tolerance towards drugs which gave a lot of event goers a further sense of security.

The organisers held regular meetings with all relevant staff and stakeholders, and if a problem or issue was identified, it was dealt with swiftly and effectively.

This newsletter is jointly produced by the Timaru District Council Alcohol Licensing Team, the Police Alcohol Harm Reduction Officer and the Community and Public Health Alcohol Licensing Officer.

We encourage all licensees to circulate this newsletter to all staff, especially Duty Managers.

As well as the great variety of music with three acts on at three different stages simultaneously, there was a wide range of food, refreshments and other entertainment.

Water was readily available and was welcomed because of the heat and some energetic dancing. The event was promoted as a family event, and as well as families it brought out some colourful characters.

Deadlines this year are:

- Easter 2020 applications must be received by Thursday, 12 March 2020
- ANZAC 2020 applications must be received by Wednesday, 25 March 2020

POLICE UPDATE

Greetings again everyone from the Alcohol Harm Reduction Police Desk. Those that follow the news particularly in Canterbury and Christchurch lately may have noticed an increase in stories and incidents involving gangs.

While gangs have always been around for a long time, and Timaru itself still has something of a reputation as a 'gang town' due to events long before I donned the blue suit, they have always been a bit up and down in terms of presence and visibility.

Following two events in particular they have been noticed a lot more and their numbers are thought to have significantly increased in terms of both variety and pure numbers.

With Australia passing amendments to their immigration laws that send criminals back to NZ it is known to have returned many individuals that were associated, or members of, different gangs whilst they were in Australia.

The second is thought to be due to the rebuild in Christchurch following the earthquakes that brought an influx of tradies and labourers into the city including those that associate with gangs.

The latest to hit the headlines has been the Mongols who have been in the media multiple times of late for events in Christchurch.

The Mongols started in the USA and are the self-proclaimed "baddest bikie gang in the world".

They join the likes of the Headhunters, Hells Angels, Tribesmen, Bandido's, Rebels along with the traditional Black Power and Mongrel Mob and Killer Bee's amongst others.

Whilst there is nothing to suggest the gangs are infiltrating licensed premises and bars in Timaru I urge you all to be vigilant as they are great opportunities to meet, recruit and do 'their business'.

This would not only effect

your business with customers but if known to frequent any establishment routinely could be viewed negatively in terms of suitability.

A good example of the risks that may come with association is the two businesses in Christchurch that have recently been damaged in apparent attacks. One having Molotov cocktails thrown into it and the other a stolen vehicle driven through the front window.

Whilst I have no knowledge of the details surrounding these incidents and cannot speculate the motives the media have no such qualms and have been giving them plenty of attention.

Throughout the history of gangs in the world there have been violent clashes between rivals and often these have occurred in bars or outside them. It may seem harmless enough allowing one group entry but it could quickly be beyond your control if a second rival group were to arrive.

Keep yourselves, your staff and your customers safe as we all work towards reducing harm in our community.

Easter Trading Hours Compliance

Police will be actively monitoring licensed premises over Easter.

This year licensees can expect to see Police checking compliance over Easter with the Sale and Supply of Alcohol Act 2012 as it relates to alcohol sales.

The law is clear that 'casual drinking' is not permitted under any circumstances however if customers are dining they can have a drink to accompany their meal. The Act states:

47 Sale and supply on Anzac Day morning, Good Friday, Easter Sunday, and Christmas Day restricted: onlicences

 The holder of an on-licence must ensure that no alcohol is sold or supplied on the premises on Good Friday, Easter Sunday, or Christmas Day, or before 1 pm on Anzac Day, unless –

- (a) it is sold or supplied while the holder also holds a special licence for the premises; or
- (b) the buyer is a person of a kind described in subsection (2).
- (2) The kinds of person referred to in subsection (1) are
 - (a) people residing or lodging on the premises:
 - (b) people who are present on the premises to dine.
- (3) For the purposes of subsection (2),
 - (a) a person resides or lodges on licensed premises if he or she resides or lodges in the building in which the premises are situated as the guest, lodger, tenant, or employee of the licensee:

- (b) a person is not present on licensed premises to dine if he or she is there at a time –
 - (i) more than an hour before he or she starts (or is due to start) eating a meal; or
 - (ii) more than an hour after he or she finishes eating a meal.
- (4) Subsection (1) is subject to section 173 of the Gambling Act 2003.

Police are aware that in recent years there has been considerable pressure applied by a few casual drinkers to be served and Police expect licensees to have good systems in place to prevent this occurring.

Sports clubs' end of season prize-givings

A reminder to plan ahead for your end of season sports events. For clubs that don't hold a club licence you will need to apply for a special licence for any end of season prize-giving.

For licensed clubs prize-giving events often include the general public so a Special Licence is required if you wish to sell them alcohol. Unsure? Give the Alcohol Licensing Team a call and they will be happy to discuss this with you.

LCQ Training Dates

In the Timaru / Waimate / Mackenzie district there are two providers that offer NZQA Unit Standards 4646 and 16705 training.

Everyone has different ways of learning for some it is face to face training in a classroom environment whereas some people prefer online. We have both available in our districts.

The ARA course dates for 2020 are below (however may be subject to change):

4th May, exam on 19th May 8th June, exam on 22nd June

27th July, exam on 8th August 19th October, exam on 2nd November

(The course runs 8.30am to 4.30pm on the first day and the exam starts at 1.00pm)

As well as the ARA courses there are also the online version which is done through another organisation called GetLCQ (located in Dunedin) and their website is www.getlcq.co.nz if your staff would prefer to do it online.

In previous newsletters we have discussed Servewise and this is excellent for those staff that you have working behind the bar who may not wish to go to the next level of obtaining their LCQ. This is a free training system and you can access this by going to www.alcohol.org.nz and search for 'Servewise'.

Generic Email Address

We now have a generic email for any electronic forms that you may wish to lodge. The email address is liquoradmin@timdc.govt.nz and this is accessible by the Liquor Licencing Team. This should only be used for lodging forms (be it new/renewal applications or even your Notice of Management Change Forms). We will be updating our forms in the near future to include this email address so watch this space.
