In ONF 4 the value of the Claremont Bush is mentioned in the evaluation, but even there this is not included in the ONF. Also, below ONF 4 is a limestone area which is classified as a SNA.</i>	ONF 1 Kakahu Bush: As above, but also the limestone part needs to be extended to the north.

While the rock outcrops are the dominant features, the overall landscape impression is created by the situation of these being on top of a high slope. This slope needs to be part of the ONF down to the foot of the slope. If for example a plantation forest would be established on the slope, this would change the landscape impression considerably. In ONF 4 the value of the Claremont Bush is mentioned in the evaluation, but even there this is not included in the ONF. Also, below ONF 4 is a limestone area which is classified as a SNA.</i>	ONF 2 'Hanging Rock': As under general, because this is a dominant feature above the river. It also needs to be extended to the west and east especially to include the whole escarpment with the full Taniwha Valley. The limestone feature along the Raincliff Road could be included as well. I would recommended to check the name for this ONF, because 'Hanging Rock' is generally considered to be on the other side of the Opihi (where the bridge ends).
