Taking into account the historical significance of Church outlined in the documents accompanying the submission, I am aware of the significant time and effort - much of it voluntary - already invested into plans and consents in order to ensure the preservation of St Peter's Church for the Temuka community both now and into the future. The Parish currently has a window of opportunity to make the preservation of our Church possible through legally required earthquake strengthening.
