6.1 Sustainable South Canterbury Trust - Contract Renewal

The Waste Operations Manager presented on partnership with Sustainable South Canterbury Trust, which had been on a rolling contract since 2019, and the opportunity to redo contract so it's current and forward looking. Supports the goals of waste minimisation in line with waste levy funding requirements. Comes at no cost to ratepayers as it's externally funded with strict requirements on what is allowed to be funded.

Discussion on the level of waste levy, whether it could be used for other priorities such as closed landfills and whether we get the levy back for waste coming into our district from elsewhere. Discussion was also whether the living wage should be specified in the TDC contract or if that is an issue for the Trust to resolve with its own staff.
