PHYSICAL DESCRIPTION

Single-storey dwelling with rectangular footprint and gabled roof forms. Twin-gabled wings on east-west axis abut gabled bay running along west side. Latter features a faceted bay window on south-facing facade. Return veranda on west, south and east elevations. Double-hung sash windows. Lean-to at rear (north elevation).

MATERIALS/STRUCTURE

Concrete, timber, brick and corrugated metal.

ADDITIONS/ALTERATIONS

Veranda and weatherboard lean-to additions (date unknown).

SETTING

The farmhouse stands to the west of the township on the north side of the Pleasant Point-Cave Highway (SH 8). The property is bound to the east by Maze Road. The extent of setting is limited to the immediate environs of the house, notwithstanding the potential archaeological values of the land parcel as a whole.

HISTORY

Robert Worthington (1844-1920) was the son of Captain Edward Worthington of Guernsey in the Channel Islands. According to family history sources, Edward did not want his sons to join the Royal Navy and so sent Robert and his younger brother John, both of whom were born in Tours, France and spoke French fluently, out to New Zealand in 1861 to take up sheep farming. Robert had bought land in Pleasant Point by 1865 and appears to have settled there in 1866. John also moved to Pleasant Point where he became the pound keeper. Family history records that both men lacked practical skills, having been brought up with servants, and so therefore struggled to make a living, especially during the depression of the 1880s. Robert Worthington married Catherine Jagger in St Mary's Anglican Church, Timaru in June 1869 and the couple initially farmed in Te Ngawai Road. Robert was elected to the first local school committee in February 1869. The Te Ngawai Road property, which included a fourroom stone house, was put up for sale in August 1877, suggesting this may have been when the Maze Road farmhouse was built. The latter property was for sale in March 1882 but appears not to have sold as it was being marketed on the Worthingtons' behalf a year later. Robert Worthington was declared bankrupt in August 1883, which may account for his desire to sell his second, smaller Pleasant Point farm. (Worthington later ran a livery stable in Pleasant Point, but he died in Christchurch.) The farmhouse was then acquired by Michael Maze (c.1841-1917), who applied to the Geraldine County Council for a slaughterhouse license on the property in August 1887. According to his obituary Maze was a well-respected horse breeder and a life member of the Timaru A & P Association. It appears the property remained in the Maze family until the late 20th century; the farmhouse is still in ruralresidential use today.

HISTORICAL AND SOCIAL SIGNIFICANCE

The former Worthington / Maze farmhouse has historical significance for its association with the Worthington and Maze families and the development of farming at Pleasant Point.

CULTURAL AND SPIRITUAL SIGNIFICANCE

The former Worthington / Maze farmhouse has cultural value as a demonstration of the way of life of the families who have resided in the dwelling since its construction.

ARCHITECTURAL AND AESTHETIC SIGNIFICANCE

The former Worthington / Maze farmhouse has architectural value as a mid-Victorian villastyle farmhouse rendered in permanent materials.

TECHNOLOGICAL AND CRAFTSMANSHIP SIGNIFICANCE

The former Worthington / Maze farmhouse has technological and craftsmanship significance for its concrete construction. The house is noted in Geoffrey Thornton's definitive history of concrete construction in New Zealand.

CONTEXTUAL SIGNIFICANCE

The former Worthington / Maze farmhouse has contextual value as a historic feature within its rural setting and for the contribution it makes to the historic character of the Pleasant Point area.

ARCHAEOLOGICAL AND SCIENTIFIC SIGNIFICANCE

As the farmhouse pre-dates 1900 its site has potential archaeological significance relating to the dwelling's construction and the development of pastoralism at Pleasant Point.

SUMMARY OF HERITAGE SIGNIFICANCE

The former Worthington / Maze farmhouse has overall heritage significance to Pleasant Point and Timaru district as a whole. The farmhouse has historical significance for its association with the Worthington and Maze families and the development of farming in the area and cultural value as a demonstration of the way of life of its former residents. The former Worthington / Maze farmhouse has architectural value as a mid-Victorian vernacular farmhouse and technological and craftsmanship significance for its concrete construction. The former Worthington / Maze farmhouse has contextual value as a historic feature on the outskirts of Pleasant Point and its site has potential archaeological significance in view of the building's pre-1900 date of construction.
