#### 6.1 Coastal Erosion Environment Canterbury Update

General Manager South Canterbury of Environment Canterbury and Regional Council Natural Hazard Scientist presented an update to committee members on the coastal erosion occurring along the Timaru District Coastline and the actions Environment Canterbury is undertaking on this matter.

Key Points included; Update to coastal hazard issues occurring within the Timaru District, Niwa Coastal Inundation Report, Jacobs Coastal Erosion Report, Interactions with public and issues facing the public, multi-agency discussions, long term issues and actions, contamination of flood water.

It is advised Councils current legislative framework as it relates to land use is not fit for purpose for some of the inundation issues currently being faced from coastal erosion.

Confirmed damaged stop bank near Milford Huts will be repaired.

#### 6.2 Tsunami Evacuation Zone Review

Senior Scientist Natural Hazards from Environment Canterbury and Team Leader and Emergency Management Advisor from the Timaru District Council presented a review of the tsunami evacuation zone within the Timaru District.

Key points included: How tsunamis are created and the impact of variants, comparison of the 2012 and 2022 evacuation zones, model of tsunami height and hazards, past tsunami history, GNZ science tsunami modelling, information on Tsunami warnings and action map, impacts of Alpine Fault.

Confirmed communications with communities that are affected including at risk members. Timaru District does not require separate provisions in the District Plan, as the Timaru Coast inundation which is considered for land use planning is about a 500 year return period and is covered in the other coastal hazards.
