Sites and Significance to Māori

My property which is 360 Arundel Rangitata Road, RD 22, Geraldine has been identified as having SASM Wai Taoka on its land, which is the following 'These are waterway-based places that are treasured due to their intrinsic values and critical role in sustaining life and providing for needs of present and future generations. Examples include repo raupō, wai puna and mahika kai. It is proposed that consent is required for earthworks, buildings and structures, plantation forestry, mining and quarrying and intensively farmed stock within these areas; and there are controls on indigenous vegetation clearance', as stated on the council website under definitions. We are concerned that the restrictions placed on our land and what it means we can and can't do. We have further concerns around the mapping of these SASM's. The accuracy of this is very questionable and we hope the council will undertake a better mapping of the areas. It is important for the council to remember that these are private property that the council is mapping, and it is important to get mapping right. We suggest and urge that if there is a suspicion that maps may be incorrect then the council redoes the mapping in a more comprehensive manner.

As a result of our concerns around the mapping and mistake that the council has accidentally put our property into the overlay where we have evidence from a resource consent that was granted by the Timaru District Council (TDC) in 2012. This report was commissioned by us by Irricon Resource Solutions LTD and was in regard to LAND USE NO.102.2012.650. The report outlined that if any archaeological material, work shall cease and appropriate runanga should be notified. This is something as landowners we agree with and is like PER-2 in SASM-R1 which we support as an important part of protecting New Zealand's history and heritage. As landowners we acknowledge that the area surrounding our farm was used by local Māori as a place to live and grow their food. The report from 2012 also stated, which is

attached in appendix 1, that the site is "not known to contain any archaeology or have any special significance to Takata Whenua". The report later states that "it is considered that adverse effects on the environment in terms of culture will be or are likely to no more than minor". As the owners of the land, we seek this as evidence that our land has been inadvertently captured in this mapping when it should have not been. This document is on council records and should of be something they should have gone through before releasing the plan, causing stress and anxiety among the rural community. We hope the council will do more due diligence in further plans.

We request the council to remove us from the SASM quickly before any effects of this classification can cause disruption to our business and farm operations. We understand that councils from time to time make mistakes and hope this submission will allow for addressing of such wrongs. This has caused us significant stress around our farm management. We hold an intergenerational view and would like to protect the farm and its lands for future generations to enjoy.

We thank the council for the opportunity to submit on the proposed District Plan.

5.2.7 Effects on Culture

The site does not contain any listed heritage buildings, nor is it located within a heritage precinct. This site is not known to contain any archaeology or have any special significance to Takata Whenua.

The applicant has proposed mitigation measures, for instance, ceasing work and contacting the appropriate Runanga should any earthworks/excavation on the site reveal any archaeological material. Work will not recommence until given approval from the Runanga.

Should the consent be granted, a condition relating to the above stated mitigation measure will be imposed in the decision.

Accordingly, it is considered that the adverse effects on the environment in terms of culture will be or are likely to be no more than minor.
