NZTA-1 Designation Conditions

1. A 300m length of “Open Graded Porous Asphalt (OGPA)” quiet road surfacing, or an alternative form of quiet road surfacing that will achieve at least the equivalent traffic noise level, will be maintained between meterage points 5900 and 6200 shown on the aerial photo below to ensure traffic noise levels at 7 Talbot Road, 12 Ellis Road and 10 Ellis Road meet or remain within levels recommended by the Transit Guidelines.
2. A 400m Length of OGPA quiet road surfacing, or an alternative form of quiet road surfacing that will achieve at least the equivalent traffic noise level, will be maintained between meterage points 6400 and 6800 shown on the aerial photo below to ensure traffic noise levels at 14 Daniels Road, 16 Daniels Road and 11 Normanby Road remain within the 1999 Transit Guidelines.⁵
