
Hi,

On behalf of the Catholic Diocese of Christchurch (further submitter # 262) I have reviewed Decision-Appendix 3-71-MEDU-Panel Edits. I note that there is a typo in the Designation Schedule for Sacred Heart Primary School within the designation site identifier.
