RE: Proposed Timaru District Plan Hearing Stream A: updated Hearing Statement on behalf of Silver Fern Farms Limited (submitter 172)

- 1. We act for Silver Fern Farms Limited ("Silver Fern Farms") who lodged a submission and further submission on the Proposed Plan.
- 2. On 7 November 2023 Silver Fern Farms provided a Hearing Statement in respect of Hearing Stream A for tabling with the Hearings Panel. That Hearing Statement noted that Silver Fern Farms will not file evidence on the matters in the scope of Hearing Stream A.
- Since that Hearing Statement was provided, the s42A reports and recommendations on provisions Silver Fern Farms submitted on have been amended, as set out in the updated s42A reports dated 5 April 2024, below:
