1 Apologies

There were no apologies.

2 Public Forum

Ian Jackson attended the meeting to discuss road management, speed and trucks on Wood Street. Ian noted sunken footpaths, blocked drains and vehicles over property entrances. After phoning Council these items were remedied. There are still issues with vehicles not adhering to speed limits and Ian is concerned that there will be an accident. He is also concerned around the weight limits for this road and vehicles not adhering to this rule. Ian also noted issues with teenagers knocking bins over and the lack of Police presence in the area.

The Transportation Team leader advised that the trucks are not allowed to proceed all the way down Wood Street when they are loaded as there are weight limits on this street.

Cr O'Reilly suggested we send letters to the transport businesses to advise them that they should not be proceeding down Wood Street loaded.

The Transportation Team Leader will discuss the assessment of the road with the Infrastructure Manager and make suggestions for remedies. Council to provide an update to Mr Jackson.
