Oppose	These enlarged flood risk areas include land that is at no risk of ever flooding given their distance from any river, stream or ephermal waterway. For example, large areas of our farm have been deemed a flood risk when they are 30m above the Opuha and Opihi rivers and up to 500m away from any other waterway. Should these areas be deemed at flood risk, they could result in higher insurance premiums, increased rates costs and higher building costs amongst other things.	Disallow in part	Correct the flood risk areas to include only land that is actually at risk of flooding and exlcude those with no risk of flooding. This needs to take into account proximity to waterways, the size of any catchment areas, the slope and elevation of the surrounding land
