7 Reports

7.1 Earthquake-Prone Building Update

The committee was provided an update from the Building Control Manager on progress with the Earthquake-Prone Buildings Project for the Timaru District.

Good progress has been made to date and the process is tracking well. The statutory timeframes provided do give plenty of time to work through this part of the process.

Engagement with the community includes workshops which give the public attending a chance to gain an understanding of the process, who can assist them and the opportunity for questions.

The Earthquake-Prone Building project is not currently causing any problems with the normal service delivery as there are dedicated resources within the building unit

Discussion was held about central government providing financial assistance for Wellington buildings and that building owners feel uncertain how this process will affect the values of their assets. Group Manager Environmental Services advised that the building unit has a very clear role as the regulator. However the unit is committed to providing as much information as possible to affected building owners, links to other organisations that can assist them, including potential funders. Elected members could consider options such as advocating to central government for funding assistance on behalf of building owners and the potential for Council funding assistance as part of the Long Term Plan process.
