# **Final Proposal** for Representation Arrangements for the 2019 Local Elections



On 16 October 2018, the Timaru District Council considered the submissions received on its initial proposal regarding the representation arrangements for the Council and its constituent community boards to apply for the local elections to be held on 12 October 2019.

The Council received 1 submission, which was in support of the proposal.

Having considered the submission, the Council resolved to adopt its initial proposal as the final proposal with no changes.

# In summary, this is:

# **Timaru District Council**

- Mayor elected at large
- Councillors --- Nine (9) Councillors as follows:
  - Geraldine Ward (based on current Geraldine Ward Boundary) One (1) Councillor
  - Pleasant Point Temuka Ward (based on current Pleasant Point Temuka Ward Boundary) – Two (2) Councillors
  - Timaru Ward (based on current Timaru Ward Boundary) Six (6) Councillors

The three wards reflect the following identified communities of interest:

In accordance with section 19V(2) of the Local Electoral Act 2001, the population that each member represents must be within the range of 5,232 +/- 10% (4,709 to 5,755), unless particular community of interest considerations justify otherwise. All three wards are within the stipulated range.

# Geraldine Community Board

Six (6) elected members from the Geraldine community as a whole and one (1) appointed member, (the appointed member being the Geraldine Ward Councillor).

# **Pleasant Point Community Board**

Five (5) elected members from the Pleasant Point community as a whole and two (2) appointed members, (the appointed members being the Pleasant Point-Temuka Ward Councillors).

# **Temuka Community Board**

Five (5) elected members from the Temuka community as a whole and two (2) appointed members, (the appointed members being the Pleasant Point-Temuka Ward Councillors).

The three boards reflect the following identified communities of interest:

#### Reasons

There are no changes proposed to current representation arrangements for the reasons listed below:

- All wards comply with the legislative requirements and provide for fair representation;
- The growth patterns predicted in the District Growth Strategy indicate that compliance will continue in future years;
- The existing ward and community board structure is well understood by the electors;
- The Council is satisfied that the existing structure will continue to provide effective representation for the District's distinct communities of interest; and
- No significant changes have occurred since 2012 to indicate that the Council should be proposing changes to its representation arrangements at this time.

# Appeals

Any person who made a submission on the Council's initial proposal may lodge an appeal against the Council's decision. An appeal must relate to the matters raised in that person's submission.

# **Procedure after Close of Appeals**

The confirmed representation proposal is open to appeals until 20 November 2018. The appeals must identify the matters to which the appeal relates and may only raise those matters that were raised in the appellants' submissions on the initial proposal. All eligible appeals are forwarded to the Local Government Commission.

Should an appeal(s) be received, the Local Government Commission will consider the Council's final proposal together with any appeals. The Local Government Commission *may* hold hearings with those who made appeals. These hearings *may* take place in the Timaru District. The Local Government Commission makes a final determination which is only subject to judicial review in respect of matters of law.
