Sister City Relationships and Visit						

# **Purpose of Report**

- 1. For the Community Development Committee to consider the Mayor and Chairman of Community Development to travel overseas to visit our Sister City Eniwa, Japan as part of the 10 year Sister City anniversary of our two cities.
- 2. The purpose of the visit is to further economic development between the two cities, support the three local students who will be travelling to Japan as part of the reciprocal student exchange and attend the 10 year anniversary celebration.

# **Background**

- 3. A delegation from Eniwa visited Timaru in February 2018 to commemorate the 10 year anniversary of the sister city relationship between Timaru and Eniwa. The Mayor of Eniwa has invited a delegation from Timaru to visit Eniwa in July to commemorate the anniversary.
- 4. Three local students will be visiting Eniwa as part of the annual reciprocal student exchange which takes place each year. We have a strong relationship with Eniwa on educational exchanges as well as local students travelling and studying in Eniwa each year.
- 5. Timaru District has four official Sister City relationships. We have a very strong relationship with Eniwa, Japan which over the last term has sent delegations from its Chamber and business community up to four times per year.
- 6. The Mayor concludes that there is a solid relationship in place for further educational and economic commercial benefits to develop which is already evident through the existing education relationship we have with Eniwa.

7. The Committee can approve or decline the overseas travel for the Mayor and Chairman of Community Development Committee.
