Further to your information request dated 15 May 2018 re RC No. 102.2018.78, please see the following (numbering as per your request):

1. With regards to past helicopter movements, the application stated that 74 flights were made in 2017. This was based on the information supplied at that time. Following the s92 request the relevant operators were contacted again, which provided addition detail, but also indicates slightly differing information. The updated information for the rescue helicopters landing Timaru Hospital is as follows:

<sup>\*</sup>Actual number not supplied. But it was noted by the operator that 2016 was slightly less than 2017, and it was suggested by the operator that the 2017 figures could be used.

The above indicates that the majority of flights are during the day, with night time flights averaging once every 2 and half weeks.

In terms of information prior to 2015, this was not supplied.

- 1. Peer review mitigation measures to be progressed by the expert meeting.
- 2. Reinstatement of the kerb and channel was not proposed as part of the application, but if considered required, then please make a condition of consent.
- 3. It is anticipated that the proposal will comply with Part D2, Rule 5.17-5.18 as any lighting for on ground activities will be directed downwards, and any lighting associated with helicopter arrival will be directed upwards. Final lighting design and confirmation can be included as a condition of consent.
