Building Act 2004: Schedule 1, Part 1 (building work not requiring building consent) Section

30 Demolition of detached building

The complete demolition of a building that is detached and is not more than 3 storeys.

Section 31 Removal of building element

The removal of a building element from a building that is not more than 3 storeys, provided that the removal does not affect —

(a) the primary structure of the building;or (b) any specified system; or (c) anyfire separation.

A Building Consent may not be required prior to a demolition or removal of a building or part of a building HOWEVER if you intend to demolish or remove a building or structure from your site, a building consent would ensure that all related services are capped / sealed, that the site is fully cleared, and that the Timaru District Council files and rating assessments correctly reflect these changes.

Planning requirements

Resource consent may also be required if buildings have a heritage rating under the Timaru District Plan.

Please talk to Timaru District Council Planning staff if you have any queries.

Drainage and water requirements

A services consent may be required for the disconnection of existing drainage and water services.

Please talk to Timaru District Council Drainage and Water staff if you have any queries.

Please ensure all connections are capped off and accurately mapped.

Other matters

If you suspect that the building has hazardous material contact Worksafe New Zealand <u>worksafe.govt.nz</u> and Community and Public Health <u>cph.co.nz</u> for help and information. Dispose in an appropriate landfill.
